It was founded in 1955 by an active group of parents of children with developmental disabilities who wanted more for their children than the limited options available at that time. Since then, The Arc has advocated for and provided support to people with developmental disabilities and their families.

We are accredited by the Commission on Accreditation for Rehabilitation Facilities (CARF) in twelve program areas.

The Arc of Carroll County is affiliated with The Arc of Maryland and The Arc of the United States. These organizations help to advocate for people with developmental disabilities through statewide and national legislation.

We receive funding from state and local governments to provide essential services to people with intellectual and developmental disabilities. Those funds support about 75% of the actual cost providing those services. The remaining 25% comes from the generosity of people like you.

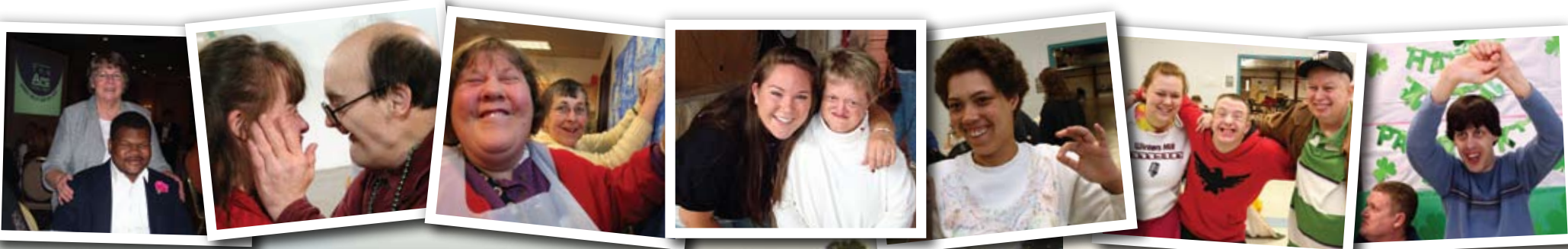
